Admission Requirements and Lawyer Bar Exam Results

Applicants must complete all of the requirements through the [online admissions site \(https://admissions.wsba.org/\)](https://admissions.wsba.org/). See the [New Admittee Process Instructions \(/docs/default-source/licensing/admissions/scoring-and-nap/new-admittee-process/nap-instructions-9-27-17.pdf?sfvrsn=7fab3cfl_45\)](/docs/default-source/licensing/admissions/scoring-and-nap/new-admittee-process/nap-instructions-9-27-17.pdf?sfvrsn=7fab3cfl_45) for more information.

After an applicant has met all the requirements for admission, the applicant will be recommended to the Washington Supreme Court for admission to the practice of law in Washington. Upon receipt of the Admission Order from the Court, the WSBA will assign

the new admittee a license number and send the admittee by mail a Bar card and a certificate from the Court. Applicants are not permitted to practice as a lawyer until the Court signs the Admission Order and the applicant receives the Bar card and license number.

Applicants who have passed the Washington UBE have 40 months from the date of the examination to complete the [New Admittee Process \(/docs/default-source/licensing/admissions/scoring-and-nap/new-admittee-process/nap-instructions-9-27-17.pdf?sfvrsn=7fab3cf1_45\)](/docs/default-source/licensing/admissions/scoring-and-nap/new-admittee-process/nap-instructions-9-27-17.pdf?sfvrsn=7fab3cf1_45), and be licensed as a lawyer. Admission by Motion and Uniform Bar Exam (UBE) Transfer applicants have one year from the date of the application submission to become licensed in Washington.
